In Glenn Hinckley's four page list of cobblestone structures published in 1993, on page 4 he lists "Lost Examples". His #39 on that list is "B. Davis Noxon House, Buckley Rd, Salina, Demolished." He cites no references and provides no information other than this simple statement.

There are, in fact, two houses on Buckley Rd, essentially across the road from one another (one north and one south of 7th North St)—one labeled 'B D Noxon', the other "B D Noxon Jr". Which of these two might be the referenced cobblestone is unknown.

Extensive research has yielded absolutely nothing to substantiate the alleged cobblestone ever existed. Lacking evidence, I consider this to be a red herring until something is found to prove otherwise. I list it here to indicate that it has been researched<sup>1</sup>.

<u>Atlas:</u>	1852: 'B D Noxon'(s) and 'B D Noxon Jr' (n); 1859: 'BDN' (both) 1874: "Powers & Nutting"; "B. Gare"? <sup>2</sup>
<u>When Built/Mason:</u>	No information found
<u>When Razed:</u>	No information found
<u>Original Owner:</u>	Unknown (possibly the Noxon family is the original owner)
<u>Subsequent owners:</u>	Unknown Other than wall maps, there are no references to their residences
<u>Original Use:</u>	Unknown
<u>Subsequent Use:</u>	Unknown

<sup>1</sup> Glenn Hinckley email, 11/5/2017: My old 3x5 note cards give the reference for this house as "cobblestone society". Back in the early 1990s when I went there to do research, this house was on their list, but I do not remember what their source was. Most of my information about BDN comes from the newspaper sources that you gave me, and the rest from [ancestry.com](https://www.ancestry.com). This one may also be on Richard Wright's handwritten research list. I need to check on that at OHA. I wish I had more confirmation that this was a cobblestone, but so far none has turned up. OHA: Onondaga Historical Association

Parents: Dr. Robert Noxon and Hester Davis

Son of a physician. Prominent lawyer in Central New York, located in Onondaga Hill. Had no peer in real estate law. Moved to Syracuse in 1829 and formed the law firm of Noxon & Leavenworth, the leading law firm in the village for several years.

His namesake son was also prominent in law and politics and also rests in Oakwood Cemetery.

Remarks of Hon. C. B. Sedgwick — ... After reciting the end manner of Mr. Noxon's death, the speaker gave a brief sketch of his life of which the following are the most salient points. B. Davis Noxon was born at Poughkeepsie in the year 1788. His father was a practicing physician in that beautiful village. He received a good academy education and afterwards studied his profession. At that time Onondaga was a part of the far west and hither Mr. Noxon came about the year 1809, and first settled in Marcellus. Not far from this time came other young men, full of promise and glowing with ambition, who attained a high scale in their profession. Soon after his removal to Marcellus, Mr. Noxon was married to a young lady from Poughkeepsie who still survives him and is justly entitled to the love and veneration of a large circle of children and grandchildren who survive.

After a few years' residence in Marcellus Mr. Noxon moved to Onondaga Hill, then the county seat, and for many years the chief center of business and political influence. Then his professional life really began, and great victories were achieved in the important litigation that grew out of the military land grants made to the soldiers of the revolution. ...

In 1829 when public improvements had changed the business centre at the county to this place and a new Court House was built, Mr. Noxon came here from Onondaga and formed, with General Leavenworth, the law firm of Noxon & Leavenworth. For several years it was the

leading law firm in this then growing village, and Mr. Noxon's services as counsel were sought in all the important trials in the county.

Mr. Sedgwick would sum up the character of Mr. Noxon in the language of one of the most accomplished judges of the district (Wm. F. Allen):

"He was a great man, worthy of all admiration; he was strong in his nature, good sense and sound judgement; strong in a knowledge of the law, in the rudiments and principles of which he was thoroughly rooted and grounded; strong in his knowledge of human nature and his ability and tact in the use of that knowledge; strong in his self-reliance; strong in his affections and social ties, drawing to himself with the cords of love, respect, and affections all who came to know him; strong in his love of right and justice, truth, and equity."

DEATH OF B. DAVIS NOXON. - B. Davis Noxon, Esq., one of the oldest and worthiest residents of this city and county, was killed yesterday afternoon, by being struck by a locomotive of an Oswego Road freight train. He was at the time walking on the track, at the outer bounds of the city, and when the signal whistle blew, half turned around for a moment, then moved ahead again, and was in the act of stepping off the track as the locomotive struck him. He was thrown several feet, receiving a scalp wound, but not otherwise disfiguring him. But the shock was sufficient to end the life of one of his years and condition.

This is an exceptionally long article, with fond remembrances by his fellow associates in the court about his integrity, etc. I picked out a couple passages, but definitely is worth the time to read the entire four column article.

"He was passionately fond of agriculture and horticulture... I should do injustice to Mr Noxon's character if I omitted to state that one of his noticeable points was a love of nature. He took the greatest delight in his garden. I think in the height of his fame as a lawyer he was more gratified to raise a good seeding plum, which should bear his name, than to win the weightiest cause in court. His hours of leisure and relaxation were spent in his garden... never had any enjoyment more than he found in his orchard and garden at Green Point.

B. Davis Noxon, Sr., was killed at the freight yards in this city this afternoon by a freight train  
He was 80 years of age, and one of the oldest lawyers and most prominent men in Central New York.
